#### **LEGISLATION CHANGES:**

On the 1<sup>st</sup> July changes in legislation were introduced: The healthy homes standards, changes to our employment laws, and benefit rates.

As previously announced the Govt intends to remove the ability to deduct interest as an expense from income arising from residential property.



Three key points around Brightline are: 1)If you acquired your investment residential property before 27 March 21 there is a phase out period over four years.

2)What constitutes as a new house is going to be an interesting read.3)These rules only apply to rental houses – there are some exemptions.

#### TO JAB OR NOT TO JAB?

As the Covid-19 vaccine rollout draws closer, it brings with it a number of questions for employers.

Monitoring and managing the vaccinations with your staff is a reasonable and justifiable thing to do in respect of the business operation and duty of care. The simplest and quickest way is to set up a simple 'Staff Check' form with Name, Date & Vaccinated in your Employee Files. **Micaela can help with this!** 

#### SICK LEAVE ENTITLEMENT

The Government approved the increase of employee's sick leave entitlement from **5** days to 10 days, effective 24 July 2021. The extra 5days would become available on the anniversary of the employee's sick leave entitlement, that is six months after the employee started employment, then each 12month anniversary thereafter.

Because this is a legislative change, there is no need to sign variation agreements, but you do have to abide by the new laws. A general notice of the change informing all staff of this entitlement is a sign of good faith and recommended. We have drafted a general notice for our clients.
