Parental Leave Payment Increases

Parental leave payments will increase by 6.33% from Friday, 1 July 2022, to match the rise in the average weekly earnings.

The maximum weekly rate for eligible employees and self-employed parents will increase from \$621.76 to \$661.12 gross per week.



Cost of Living Payment

As part of Budget 2022, the Government announced the introduction of a Cost-of-Living Payment of \$350 split over 3 monthly payments starting 1 August to help with the rising costs of inflation for eligible individuals.

IRD will pay the Cost-of-Living Payment automatically if you're eligible for it, you do not need to apply.
